## **Transparency & Safety**

Operations from solcoin.base.eth with a migration path to a Base Safe (multisig) for larger funds; use BaseScan's **Token Approval Checker** to review/revoke allowances; all explorer links (contract, token tracker, treasury, pool/LP) are public. **Risks:** cryptocurrencies are volatile; smart contracts can fail; do your own diligence.
