## 1) Company & Key References

Connecting a wallet enables interactions with on-chain contracts. **Transactions are irreversible** and publicly visible. You are solely responsible for private keys and

approvals/allowances. Review and revoke approvals regularly (e.g., via BaseScan's Token Approval Checker).

## 4) Nature of SOLC (Utility Only)

SOLC provides access and participation features across SOL properties (e.g., token-gated content, member pricing, allowlists, rewards). **SOLC does not grant equity, dividends, revenue share, or profit rights; it is not an investment contract, and there are no promises of price appreciation.**

## 5) User Content & License

If you submit or post content through the Services, you grant the Company a worldwide, non-exclusive, royalty-free license to host, store, reproduce, display, perform, and distribute that content solely to operate and improve the Services. You represent you have the necessary rights to grant this license.

## 6) Prohibited Conduct

You agree not to: violate laws/sanctions; use bots/sybil attacks; manipulate markets; interfere with the Services; exploit smart-contract bugs; infringe IP; or engage in harassment, fraud, or money-laundering.

Small-claims court option remains.

**30-day opt-out:** You may opt out of arbitration/class-waiver by emailing **solstaff@soundoflife.media** within 30 days of your first use of the Services with subject "SOL Terms—Arbitration Opt-Out," including your name and the wallet/email associated with your use.

You represent that you are not located in, under the control of, or a national/resident of any jurisdiction subject to comprehensive U.S. sanctions and are not a prohibited party under applicable sanctions/export laws.
