This Privacy Policy explains how SOL Sound of Life Media LLC ("SOL," "we," "us") collects, uses, shares, and protects information when you visit our websites, use SOL TV / SOL Music / SOL Culture Shop, connect a wallet, or participate in SOLC programs (including giveaways).

1) Controller & Contact

2) Information We Collect

- You provide: name, email, shipping information (e.g., AMOE entries), user content (text, images, audio/video you upload), survey responses, and support messages.
- Web & app analytics: IP address, device/OS/browser, pages viewed, referrer/UTM, session and event metrics, cookie identifiers, and crash/diagnostic data.
- Wallet & on-chain events: public wallet addresses, transaction hashes, token/NFT balances, and contract event logs (used to deliver utility features, rewards, and eligibility checks). Our automation may process on-chain events via Alchemy → n8n → thirdweb relayer to enable gasless NFT rewards.
- Platform & SDK partners (apps/web): analytics/attribution tools (e.g., Firebase/Google Analytics, Flurry, Countly, AppsFlyer) and social pixels (e.g., Meta/Facebook) to understand usage/performance and, where permitted by law, to operate marketing.

3) How We Use Information

- Provide, personalize, and improve SOL TV / SOL Music / SOL Culture Shop and SOLC utilities (token gating, discounts, allowlists, rewards).
- Operate giveaways and promotions (eligibility verification, winner contact/fulfillment).
- Detect, prevent, and respond to fraud/abuse; ensure security and integrity.
- Comply with legal obligations (e.g., tax/records, sanctions screening if required).
- Communicate product updates and transactional notices; send marketing with consent or as otherwise permitted, with easy opt-out.

4) Sharing

- Service providers/Processors: cloud hosting, app platforms, analytics, customer support, fulfillment/shipping, email/SMS, anti-fraud, and KYC vendors (if required for high-value rewards).
- Legal/compliance: to courts, regulators, or law enforcement as required.
- Business transfers: in connection with a merger, acquisition, or sale of assets. We do not sell personal data in the traditional sense. In some U.S. states, certain disclosures for advertising/analytics may be deemed "sale," "sharing," or "targeted advertising"; you can opt out (see "Your Rights").

5) Cookies & Similar Technologies

We use strictly necessary cookies and (with consent where required) analytics/advertising cookies, SDKs, and pixels (e.g., Google Analytics and Meta/Facebook). Manage preferences via our banner (where available), device/browser settings, and vendor tools (e.g., Google's opt-out add-on; Facebook ad settings).

6) Data Retention

We retain personal data only as long as necessary for the purposes above, to comply with law, resolve disputes, and maintain security. Some app-platform data may be retained per that provider's standard schedules.

7) Security

We implement administrative, technical, and physical safeguards appropriate to the data. **On-chain activity is public**by design; regularly review/revoke wallet approvals (e.g., BaseScan Token Approval Checker).

8) International Transfers

We may transfer, store, or process data in countries other than yours, including the **United States** and EEA locations used by our vendors. Where required, we use appropriate safeguards (e.g., Standard Contractual Clauses).

9) Your Rights

- California (CCPA/CPRA): right to know/access, correct, delete, and portability; right
 to limit use of sensitive data; and the right to opt out of "sale," "sharing," or "targeted
 advertising."
- EEA/UK (GDPR): right to access/correct/delete; portability; object/restrict; and to lodge a complaint with your DPA/ICO; if consent is the legal basis, you may withdraw consent at any time.
